## BAR INVOLVEMENT ENHANCES CAREER SUCCESS

REMARKS OF THE HONORABLE ANNICE M. WAGNER CHIEF JUDGE, D.C. COURT OF APPEALS AT THE SEPTEMBER 19, 2002 WBA NETWORKING RECEPTION

y special thanks to the Women's Bar Association (WBA) for this event and for the organization's consistent efforts to pave the way for women in the profession to achieve their career goals.

It is a great honor to be included among the distinguished women who are dubbed tonight as "Stars of the Bar." For I know first hand of their many contributions to the legal profession, the community, and, indeed, to the nation. I have come to respect each of them individually for their ability, good sense, courage, vision and leadership by observing them over the years at court or public functions, bar or private meetings, around the conference table, on the platform, on a panel, in meetings with Congressional and other governmental leaders, and on a host of other occasions. All provided opportunities for a glimpse at the "stuff" which undergirds their achievements. If called upon for a reference concerning their qualifications, many can comment without having to develop responses from whole cloth or research. Whether you are looking for a lawyer, board member, committee chair, judicial nominee or troubleshooter, one of these names will come to mind either for the position or for advice on who might best fill it. The simple truth is that through their day-to-day involvement in meaningful activities, they get the chance to demonstrate their abilities and interests. Bar and the voluntary bar associations, have been asked to identify people interested in serving on the Committee on Unauthorized Practice, which investigates complaints against persons who are reported to be engaging in the unauthorized practice of law. From time to time, vacancies occur on the Committee on Admissions which administers the bar examination and conducts hearings related to character and fitness of applicants. The work of the Board on Professional Responsibility, which operates the attorney discipline system, and its hearing committees seek well qualified

#### SAREER PLANNING FOR SUCCESS

ost of us spend more time working in our lives than working on our lives. The same often goes for our careers. The average professional neglects to take time out to consciously plan where they want to go, how they're going to get there and by when they want to arrive.

As a Career Coach, I consistently hear a common theme from many of my clients—the path their career has taken thus far simply occurred by happen stance. There was no real intention behind the career-related decisions they made. Rather than going after what they truly wanted, they took opportunities that just happened to present themselves. Taking this random route can obviously have serious consequences. This is how many professionals find themselves in a job that is far from fulfilling. Many individuals in this situation feel frustrated, trapped and completely dissatisfied with their work life.

#### YOU ARE CEO OF YOUR OWN LIFE!

It is important to realize that you are in passenger along for the ride. You can make your career decisions in a conscious, purposeful way instead of merely reacting to circumstances as they occur. You have the power to design your life the way you want it to be. Once you have the vision, you can then implement a plan to turn it into reality. It's about living on *purpose* rather than living by *default*. Remember, you are CEO of your own life!

#### FIRST, DESIGN YOUR LIFE

In coaching women attorneys about career planning, I suggest they begin by thinking at the macro-level. I encourage my clients to engage in what I call a life design exercise where they think about what they want their life to look like. Once you have your life vision in place, it's much easier to move forward with career planning.

- Here are some powerful questions to help you begin to develop your life design:
- What do I want my life to look like, both personally and professionally?
- What are my core values in both work and life?
- What are my personal and professional passions? Do they overlap in any way?

- ➤ What do I need in my life to be at peace, fulfilled, happy?
- > What gives me a sense of purpose?

These are just a few questions to help you embark on your own life design process. I encourage you to spend some quality time reflecting on these questions. After you've pondered them, write down your answers and then come up with additional questions to flesh out your personal life vision. Remember, you can manifest any objective you have for yourself. The first step in making that happen is to develop a crisp, clear vision of your goals. As the saying goes, "A goal is a dream with a deadline."

#### CREATE YOUR CAREER MANAGEMENT PLAN

The best way to turn your vision and goals into reality is to create a career management plan with specific timelines and deadlines. This is how you can make the overwhelming task of managing your career more achievable. Many people get stuck in this area because, as I mentioned earlier, most people spend more time *doing* instead of *planning*. Below are the three elements integral to your career management plan:

- > Specific Outcome Goals
- > A Timeline with Deadlines
- > A Support System

To create your specific outcome goals, think ahead at least five years. Where do you want your life and career to be five years from now? Paint a mental picture of:

- Where you want to be working
- > The type of position you want to hold
- The types of projects on which you want to work
- ➤ What you want your life outside work to look like, etc.

The idea is to create the five-year vision so you can then plan backwards to achieve it. Take this five-year mental picture and identify specific outcome goals that will turn it into reality.

In addition to identifying the specific outcome goals, a timeline with deadlines is also crucial. If you don't assign specific time limits to your goals, they will languish on the vine of good intentions. Parkinson's Law states: "Work expands to fill the time available." In other words, if you give yourself six months to update your resume, it will take you six months. On the other hand, if you only have one night, you will get it done in one night.

The final ingredient in your career transition plan is a support system. It is imperative to have a support network—a few key people who will support you on your journey. As we face something big, we all need the encouragement, accountability and creative energy a few inspiring and insightful individuals can provide.

As the CEO of your own life, you call the shots on the direction your personal and professional life takes. The most important leadership skill you'll ever develop is the ability to successfully manage your own life. Create your life design and career management plan and get started on the path to living the life that is exactly right for you.

and interested bar members to serve. Each year, the D.C. Court of Appeals looks for bar members to serve on the Committee on Arrangements for the Judicial Conference. Some members of the bar serve on our Advisory Committee to the Committee on Access and Fairness to the District of Columbia Courts, which addresses issues of racial, gender and ethnic fairness in the court system and other issues of fairness. On October 4, 2002, from 9:00 a.m. until 2:00 p.m., the District of Columbia Courts will be having an important conference on Ensuring Fairness and Access to the Courts in a Changing World. This relates to the number 1 issue affecting public trust and confidence in the courts, and it is therefore, important to all of us. In addition to judicial and administrative staff of the courts, we expect to have in attendance representatives from the District of Columbia Bar, the Women's Bar Association, other voluntary bar associations and organizations and segments of our community concerned with issues of fairness and the highest quality of justice in the nation's capital. You are invited to be there, if you can, as

we examine our progress and consider our vision of a fair and accessible court system. This is another great opportunity to become involved in something worthwhile and network too.

One reality check deserves mention as I chronicle all that you are or could be doing. In spite of all the "movements" toward "equal this and equal that," you know that many, no most, if not all of us, as women in the profession, must do what I call, "juggle the pieces"—i.e., keep a lot of balls in the air. There is the spouse, child or children, mate, parent, friend, house, apartment, cooking, cleaning, shopping, etc. At the same time, Law is a demanding profession. There are only so many hours in the day. How can one possibly have time to perform well at the office, attend to these responsibilities, and engage in all of these extra activities? That is another talk. Suffice it to say for now—select well and perform well. It is better to serve on one or two committees and make a real and memorable contribution than to volunteer for five and distinguish yourself only by your absence. Put another way, in the words of an

old Greek proverb, 'Either dance well or quit the ballroom."

The ultimate value of tonight's event will depend not solely upon what you do while you are here, but upon what you do after you leave here. The evening will be a great success if each of you leave with a resolve : (1) to identify one professional or community organization to which you belong or in which you have an interest; (2) participate to the fullest extent practicable in the programs and meetings of the organizations which you join; and (3) give it your best as you meet the commitment you made when you joined. Whether it is one of the committees of the Women's Bar Association, the District of Columbia Bar or other bar associations, a court committee, your church, or the PTA, or others you may find worthy of your time and talents, the rewards will be immeasurable.

## Time Management: An Essential Skill for The Successful Lawyer BY MARGA

f all the elements everyone has to work with, none is more precious than time. Lawyers' abilities to manage their time directly affects the standard and quantity of their legal work, the quality of their job service to clients and their own job satisfaction. Especially in the current competitive legal environment, lawyers' time management skills significantly affect the degree of their professional success.

Here are a few common time management challenges and techniques for dealing with them.

#### HANDLING PAPER

Dealing with the continuous flow of paper through your office is a fact of professional life. Who hasn't experienced that sinking feeling upon seeing the enormous pile in the in-box after only a few days away the office? Without an effective plan for ling with paper, it can easily get out of hand, cluttering your desk (and credenza, and shelves, and floor), making it impossible to find the few truly important items.

Some suggestions for weathering the paper blizzard:

- The most important tool in handling paper effectively is your wastebasket. When deciding whether to keep or toss an item, be very selective about what you save. The key question should be, "Is there anywhere else I can find this information if I need it later?" It should not be, "Is there any chance I might want to look at this again?" It's probably safe to toss most of the paper that crosses your desk.
- ment is worth saving, the question becomes, "Where do I put it so that I can find it again easily?" A key principal for filing systems is *keep it simple*. A personal anecdote is illustrative: A brilliant but self-admittedly disorganized partner at a firm where I worked confessed to me recently that his short-lived attempt at organizing his files ended when he was stumped by a document that could have logically fit in several files.

In other words, it's better to have a few fat files than many thin ones. Not only is filing easier, (thus making it more likely that the document will actually get filed, rather than languishing in the "to file" file), but riffling through one of your files to find an item now and then will keep you up to date on its contents.

The best filing technique, of course, is to have a scrupulously organized, devoted secretary who never gets sick and who plans never to leave your employ. Failing this, however, it's a good idea to have at least a passing acquaintance with your filing system.

#### **TELEPHONE USE**

While the problem of telephone tag has been somewhat lessened by the advance of voicemail, all of us have played that annoying but sometimes spirited game. The following suggestions should make it easier for you to make contact with your prey, as well as make your telephone a more effective business tool.

- When you leave a message for someone to return a call, include the specific time or times that you are most likely to be available to receive the call.
- It's easy to get sidetracked during a conversation, so take a moment before you place a call to jot down the topics you want to cover. Having a written agenda will prevent the "I'll call you back when I remember" syndrome. This technique is especially useful for record keeping purposes if you write this agenda in your usual daybook, rather than a random scrap of paper.
- If your office uses a voicemail system, learn how to send time delayed messages to yourself regarding meetings, and appointments throughout the day. Knowing that you will be reminded at a specific time to get to a meeting leaves you free to concentrate on the work at hand. Here is another self-reminder technique to ensure that you remember breakfast meetings: leave a message on your answering machine at home on the day before the meeting that tells you to stick a reminder about the meeting on the bathroom mirror (where even the most blurry-eyed can't miss it).

#### **PROCRASTINATION**

Everyone procrastinates sometimes. The insidious thing about procrastination is that only you know when you are really procrastinating. Getting a cup of coffee, stopping by a friend's office to chat, or even working industriously on a low priority project are typical methods of procrastination.

Some suggestions for dealing with procrastination:

- The "start anywhere" approach. Don't worry about finding the best place or way to start, just start anywhere. If you're a perfectionist, try starting with an obvious mistake (to be edited out later), just so you 're not frozen by the idea that your first draft has to be perfect. It's far easier to get something down on paper and then revise it than it is to try to get everything exactly right the first time.
- nothing" approach. Assemble all the materials for the project, arrange them in front of you on your desk, and then sit at your desk and *do nothing* for seven minutes (by the clock). Don't even write down any of the ideas that come to you during this period. By the end of the seven minutes, you'll be itching to start. Incidentally, the reason for the seven minutes is to make sure that you sit there for seven actual minutes. "Five minutes" and "ten minutes" tend to become concepts rather than actual time periods.





#### FAMILY COURT PILOT PROJECT NEEDS VOLUNTEERS

The WBA and the WBAF are proud to be co-sponsors with the D.C. Bar Pro Bono Program and the D.C. Bar Family Section of a pilot project for the new Family Court of the Superior Court of the District of Columbia. Statistics indicate that over 65% of the litigants in the Domestic Relations and Paternity and Support branches of the Court are not represented by counsel. The Family Court Act of 2001 focused the attention of the legal community on the need for more services for families and children in the court system and provided funds for some aspects of those services. The pilot project will create a self-help center to provide information and general assistance to unrepresented individuals referred by the Domestic Relations and Paternity and Support branches of the Family Court.

The pilot project will be staffed by volunteers who have been trained in the operation of a pro se information center. Sufficient substantive information and manuals will be provided to the volunteers to be able to assist the pro se litigants. In addition, volunteers will work in teams of at least three, one of

whom will be an experienced family law practitioner. Volunteers will assist pro se litigants by: helping the litigants complete court forms, providing educational materials, providing detailed information on Family Court rules and procedures, preparing child support calculations, providing referrals to legal service providers and community agencies, providing information about free legal clinics and how to access free or low-fee legal services. The volunteers, however, will not provide legal advice. This is an excellent opportunity for attorneys from every type of practice, government, transactional, corporate, and litigation, to provide targeted, discrete pro bono services to families in the District of Columbia.

Members of the WBA and WBAF have a unique opportunity to volunteer through this project to assist families in the District of Columbia and the new Family Court. The initial pilot project begins at the end of October 2002 and runs through mid-April 2003. The self-help center will be open Mondays from 9 a.m. to 1 p.m. and Thursdays from 12:00 noon to 4:00 p.m. Volunteers are

expected to sign up for at least two four-hour shifts. If you can make this commitment for the training and at least two four-hour shifts, please call or e-mail Diane M. Brenneman, (202) 362-1161 or dmbrenneman46@aol.com.


