Eleanor Clift to Keynote Annual Dinner "Creating Pathways to Leadership"

he WBA and WBAF are pleased to welcome Eleanor Clift as the keynote speaker for the 86th Annual Awards Dinner, to be held on Tuesday, May 20, 2003, at the historic National Building Museum in Washington, D.C. The theme of this year's Dinner, "Creating Pathways to Leadership," celebrates the efforts of women and men to advance women into leadership positions.

Eleanor Clift is a contributing editor for *Newsweek* magazine, where she reports on the White House, presidential politics, and a variety of national issues. She currently is assigned to cover the emerging Democratic presidential field for the 2004 elections, and the jockeying over policy and politics

in the Republican-controlled Congress. Ms. Clift is a member of *Newsweek's* political team, and served as the magazine's White House correspondent during the Carter, Reagan, and Clinton administrations. Her column, "Capitol Letter," appears weekly on the *Newsweek* and MSNBC websites.

Ms. Clift is a regular panelist on the nationally syndicated show, *The McLaughlin Group*, and a political analyst for the Fox News Network. Playing herself, she has appeared in several films, including "Independence Day" and "Murder at 1600 Pennsylvania," as well as in the CBS television series, "Murphy Brown."

Ms. Clift and her husband, Washington columnist Tom Brazaitis, are co-authors of Madam President: Shattering the Last Glass Ceiling, described by Publisher's Weekly as "a sharp insider's view of the quest

to elect a female president . . . melding the immediacy of a breaking news story with savvy investigative journalism." Ms. Clift's new book, <u>Founding Sisters</u>, due out in October, tells the story of the suffrage movement and the passage of the 19th Amendment.



Caring for Elder Parents

s a child we thought our parents would always be there. They did not really have an age. Then growing up, we realized that SuperDad and SuperMom had their own limitations (like everybody else in the world), but that they were still very special. Well, maybe some of us had a period where we thought our parents were monsters, but we outgrew this vision. One day, we realized that they physically could not keep up with us any more and they had some deep wrinkles. That day we saw and realized they were old.

Some of us have experienced much more. We have seen our parents diminishing in energy, losing motor-skills day after day until it was not safe for them to live independently. Some of us have seen our parents losing their minds. Some of us have been able to help them fight terminal illnesses. We have watched them fighting this irreversible process of aging and—finally—reaching the end of their lives.

Many people are facing enormous obstacles in trying to find the right care for their seriously-ill loved ones. We are speaking not only of elderly parents but also of those suffering from a terminal illness or with chronic long-term degenerative disease including Alzheimer's, Parkinson's, ALS, and AIDS.

This is a very difficult period for a family. The journey starts with first—acknowledging that help is necessary—and then, sorting through a mountain of information, learning a whole new technical vocabulary (such as inpatient hospice versus home care hospice), anticipating needs in medication, medical equipment and supplies, learning what would be covered by the insurance, how to face the progress of the illness and to anticipate its duration.

Time becomes of critical importance. The primary caretaker becomes overwhelmed because the task quickly goes beyond one person's abilities. Caregivers face the risk of burnout and may become ill from exhaustion. The Academy Award Winning British movie, *Iris: A memoir of*

Iris Murdoch, by Richard Eyre, depicts a devastatingly accurate portrait of the challenges faced by a primary caretaker who has the burden of care for a person suffering from a degenerative disease. Author Iris Murdoch's adoring husband Bayley (played by Jim Broadbent) lovingly cared for his wife (played by Judy Dench) as she suffered from the debilitation of Alzheimer's disease. The round-the-clock care responsibilities ultimately jeopardized Bayley's physical and emotional health—causing him finally to accept that he needed to place his wife in an institution.

You need help. Actually you need a team of help; you need "care management." Care management is a relative new health care function. This is an efficient system with a team of competent professionals at your service for managing geriatric care. They teach you to see issues more clearly, and provide support for you—because understanding what is the best care for an elderly or seriously ill loved one can be very hard, especially the decisions it requires you to make.

On June 11th the Working Parent's Forum and Tax & Business Forum have organized a panel discussion on "Caring for Your Elderly Parents." The speakers are from two care organizations located in the Washington area: Potomac Home Support, Inc./Potomac Home Health Care (Potomac), and Care Management Associates, LLC (CMA). Potomac Home Health Care is a non-profit joint venture with Sibley Memorial and Suburban Hospitals. Judy Zeitler, a social worker from Potomac, will monitor a panel discussion on care management with the participation of two registered nurses, Angie Ortega (Potomac), and Susan Johnson (CMA), an occupational therapist, Katherine Campbell (Potomac), and a psychologist, Dr. Jackie Lapidus (CMA). Susan Johnson has been featured in The Washington Post and Washington Woman's Magazine. Also on the panel will be WBA member Geraldine Gennet, who has confronted many of these issues with her two elderly parents.

These professionals will explain how to get the necessary education and assistance to help with the burdens of the decisionmaking process. You want to deal with people trained and dedicated to improving and maximizing the quality of life of your seriously ill loved one. Care manage ment starts with assessing the patient's entire situation from health care to housing to who will be the primary support. The team can develop and ensure a strong partnership with doctors providing medical care. Such a team will help you maximize benefits of whatever health care is available to your loved one. You might be able to start with limited home care. Others may need guidance on placement or hospice care.


News From the Women's Bar Association Foundation

SPRING 2003 GRANT RECIPIENTS ANNOUNCED

As part of our Spring grant disbursements, the WBAF Board granted funding to two extremely deserving organizations:

The Empower Program, a gender-based violence prevention organization, received a grant from the Foundation to fund their fourth annual girls' conference, held on April 5th, 2003 at the University of Maryland in College Park. The conference focused on young women in the DC metropolitan area, from diverse cultural and socio-economic backgrounds. Programs included workshops on self-defense, body image, teen depression and anxiety, getting into college, diversity and respect for racial differences, and positive relationships and friendships.

The Women's Law and Public Policy Fellowship also received a grant from the Foundation to help fund one Women's Law Advocate to work in the Georgetown University Law Center's Domestic Violence Clinic as a Teaching Fellow. The Fellow will provide direct legal services to low-income women who are victims of domestic violence. The Fellow will also provide second and third-year law students with training and supervision of civil protection order cases.

NEW GRANT DEADLINES

The WBAF is a charitable organization that gives grants to the WBA and other DC area organizations assisting women and girls. Recent WBAF grant recipients include the WBA (for events like the Leadership Summit and projects like this Newsletter), National Women's Law Center, DC Employment Justice Center, The Empower Program, and Women's Law and Public Policy Fellowship Program at the Georgetown University Law School.



CHANGES TO THE WBA CONSTITUTION

At a special meeting held on March 4, 2003, the WBA membership voted to approve proposed changes to the WBA Constitution, as recommended by the WBA Board of Directors. The changes that were adopted expand the WBA Associate Member category to include non-lawyers who support the mission of the WBA (it was formerly just individuals who possess a law degree, but have not passed a Bar), and the Student Member category to include students in any institution of higher education (not just law school) who support the WBA mission. Associate and Student Members cannot vote or hold elected office in the WBA.

The WBA Board of Directors recommended expanding these membership categories to increase opportunities for non-lawyers and students to support the WBA and to broaden interest in the WBA within the local business, professional, and educational communities.
