# PRESIDENT'S COLUMN History and Activism

by male personal injury lawyers. I am only one of two female partners. I am often the only woman in depositions or trials.

This insular life has in the past isolated me from the large number of prominent women engaged in the legal profession. Through the WBA, I have been awestruck and heartened by the fellowship and contact with talented, energetic, and generous women. These connections and experiences instill an activism—to ensure that the rich history of the WBA is conveyed to each WBA member and to continue the march that began almost 100 years ago toward empowerment and influence.

Our history is indeed rich. For example:

- In 1918, the WBA worked to legitimize children born out of wedlock, a project described in the Annual Report as "the righting of a giant wrong which the world has already tolerated longer than it should." In 2003, the WBA continues advocating on behalf of children and families with our involvement in the Family Court Self-Help Pilot program. [See article p. 8]
- In 1949, President Truman appointed WBA member Burnita Shelton Matthews to the United States District Court for the District of Columbia. Ms. Matthews was the first woman in the country to serve as a federal district judge. One year later, the



WBA placed a gold plated case containing the WBA letter head and greetings in the cornerstone of the new United States
Courthouse. The WBA also secured space reserved for women in the new courthouse.
The annual reception for "STARS OF THE BAR" continues the WBA legacy of recognizing and promoting women attorneys.

Fundamental to our future is the preservation of the memory of the many women who have gone before us. They fought for the right to vote, to work in government, to serve as jurors, and to have equal opportunity to become partners, judges, and heads of agencies. Understanding our history places in context the current struggles-the glass ceiling, the elusive "balanced" work life, and the many forms of subtle bias in the profession. For that reason, Nancy Long, WBA Past President (1996–1997) and current WBA Foundation Vice President, and Karen Lockwood, WBA Board member, will serve as WBA archivists and begin to chronicle the history of the WBA. ### ABA Women of Color in The Legal Profession Launch Research Initiative

he American Bar Association (ABA) Commission on Women in the Profession is conducting groundbreaking research on women of color in the legal profession. The study will begin in the spring of 2003 with a final report to be issued in 2005.

"We are excited about this project because it will offer legal employers tremendous insight into how to retain and promote women of color," said Angela Williams, an attorney at the law firm of Bryan Cave, who is leading the research effort.

Beginning next month, focus groups will be held across the country to discuss: (1) What attracts women of color to the legal profession; (2) Do their work experiences surpass or fall short of expectations; (3) How do legal employers hinder or increase job satisfaction; and (4) Why do women attorneys of color change organizations or leave the profession.

NITA is a preeminent national in-service training institute in which senior trial lawyers volunteer their time to help lawyers sharpen their trial skills. Ms. Lockwood's appointment was announced on June 4, 2003, at a special dinner honoring the 25th Anniversary of the Georgetown/NITA program held in the Grand Hall of the United States Supreme Court Building, at which Justice Steven Breyer gave remarks.

Senior trial lawyer Kim Keenan of the malpractice law firm Jack H. Olender & Associates, P.C., was sworn in as President-Elect of the National Bar Association at its

annual convention in New Orleans. Keenan is the first woman from Washington, D.C. to be elected to serve as President of the 20,000 member organization, comprised predominantly of African-Americans. Keenan has held several offices with both the local and national legal organizations. She most recently completed her term as President of the Washington Bar Association and currently serves as Treasurer-elect of the BADC.

**Jill F. Dash** is leaving her position at the Federal Trade Commission Division of Advertising Practices to start a two-year clerkship on the Southern District of New York with Judge Laura Taylor Swain on September 2nd.





To achieve this goal, POWER provides legal services to low-income women, educates low income women and their service providers about their employment rights, and tirelessly advocates for equal rights in the workplace in the Washington, D.C. metropolitan area

POWER was founded in 2002 in response to the unique problems low-income women face in employment, especially when they have family and caregiving responsibilities. Applying a gender lens to employment law, POWER has isolated several critical areas of law relat-

ing especially to women and families: access to family and medical leave, freedom from pregnancy discrimination, and freedom from sexual harassment. Each of these rights is guaranteed by law. However, employers routinely break the law, and few poor working women are made aware of the protections available to them.

Recently, POWER Coordinator Robin Runge and legal fellow Anne Daugherty Leiter have settled a string of cases on behalf of women who have been illegally discriminated against because they were pregnant or fired when attempting to access their rights under family and medical leave laws, D.C. and federal law prohibits such discrimination, but it remains widely practiced by those employing low-income workers. In addition to trying these cases, POWER distributes easy-to-read fact sheets that educate workers about their employment rights.

In addition, the EJC runs weekly Workers' Rights Clinics where low income workers can receive free legal advice about their employment problems. Half of the 1,100 workers assisted at the clinics in 2002 were women. POWER is committed to responding dynamically to the needs of working women in our nation's capital. By ensuring that employment rights are available to all, POWER safeguards our most cherished values.



### Iudith Richards Hope Keynotes Stars of the Bar

he Keynote Speaker at the Fall Networking Event: WBA Presents the Stars of the Bar is Judith Richards Hope, member and chronicler of Harvard Law's Class of 1964. Her book, *Pinstripes and* 



Pearls: The Women of the Harvard Law Class of '64 Who Forged an Old Girl Network and Paved the Way for Future Generations was published earlier this year.

In 1961, before modern civil rights legislation, women were regarded as undesirable candidates for the study of law. Three years later, those notions were beginning to crack, at least in part due to the remarkable women of Harvard Law's Class of 1964.

The 513 graduates of this pivotal, historymaking class included just 15 women, who lay are among our country's leaders: Ingresswoman Patricia Schroeder, University of Chicago bioethicist Ann Dudley Goldblatt, D.C. Circuit Judge Judith W. Rogers, C.U.N.Y. Professor of Criminal Justice Diane R. Gordon, and their classmate and chronicler, corporate lawyer Judith Richards Hope. Elizabeth Dole graduated from Harvard Law a year later, and Janet Reno a year earlier. Pinstripes and Pearls tells the story of these pioneering and gutsy women who worked together to overcome discrimination, struggled to be taken seriouslyor just to get a job—in an overwhelmingly male-dominated profession. The 15 formed a network of friendships and alliances that is still strong and vibrant today.
