

# From Our Rich Past to Our Boundless Future







#### Meet the WBA Intellectual Property Law Forum

he Intellectual Property Law Forum provides women lawyers practicing in the intellectual property field with opportunities to advance their legal knowledge, increase professional contacts and improve the status of women practicing in the areas of patent, trademark, copyright, unfair competition, computer and technology law. The Forum's programs are targeted at women engaged in law firm, government, solo, and proporate practices.

The IP Law Forum began in 1995 and has grown over the past eight years into an active and well known resource for educational programs and networking opportunities in the Washington DC legal community. In the past, the IP Law Forum has co-sponsored programs with the Intellectual Property Law Section of the DC Bar Association and the American Intellectual Property Law Association, among others. The IP Law Forum has hosted a judicial forum attended by local federal judges, at which the judges provided insight on how to try high technology cases.

The IP Law forum is co-chaired by *Linda Alcorn* and *Rebecca McNeill*.

Linda says that her goal as co-chair is to "provide the Washington DC intellectual property community with substantive presentations on timely issues in intellectual property law and draw on the abundant local resources for speakers. In the past, speakers for our programs have included judges from the U.S. Court of Appeals for the Federal Circuit, judges from federal district courts, administrative judges from the Trademark Trial and Appeal Board and Supervisory Patent Examiners from the U.S. Patent and Trademark Office."

Rebecca concurs, adding that she also serves as a co-chair "because it gives me an opportunity to meet other attorneys practicing IP law. I also enjoy the opportunity to plan programs that will educate members of the DC legal community and help them satisfy their CLE requirements." Rebecca, in fact, initiated the WBA's recent effort to offer CLE credit at qualifying programs.

The IP Law Forum recently held several programs, including a luncheon panel discussion on the *FDA's Initiative To Combat Counterfeit Drugs* (held in conjunction with the Health Law Forum) and a *Networking Luncheon* at Sterne, Kessler, on November 5, 2003. Upcoming events include another *Networking Luncheon* on February 4, 2004, which will give women practicing in intellectual property law a chance to meet new colleagues, find mentors, and discuss practice issues in an informal environment. And, on a different note, the Forum is hosted a general interest program on *Law Firm Economics* on January 28, 2004 to help associates (and maybe some newer partners) understand the financial operation of a law firm. # Independence, Choice, the Cost of Waiting and Tax Incentives—Why Women Should Consider Long Term Care Insurance Now

any women think that they do not need long term care insurance. Women should not fall prey to this misperception, but instead should consider long term care insurance coverage to maintain their independence throughout life, no matter what happens. Women live longer than men and have different health issues. Women are three times more likely than men are to face a debilitating disease such as multiple sclerosis (MS) or rheumatoid arthritis. 1 Many of us have friends who have already been faced with symptoms that could signal the onset of such a disease or have had a serious accident. A woman who waits until she notices a decline in her health may no longer qualify for long term care insurance. Unfortunately, once a woman knows she needs long term care insurance coverage, it may be too late to obtain it.

Whether you live alone or with family or friends, long term care insurance provides resources to help care for you. Long term care insurance covers home and community care, assisted living facilities as well as nursing home care. Most people want the choice to receive care at home, in a comforting and familiar environment. Long term care insurance can make this possible.

If you have disability insurance, you have made provision to replace your income if you are disabled. However, income replacement will merely pay the mortgage and bills, not the expenses of providing the personal care you may need.


Because the cost of long term care insurance is based on your age and your health, waiting to buy insurance will cost you more. Furthermore, if a person is eligible for discounts, such as those for good health, spouse or partner discounts, or sponsored discounts such as those available to WBA members and relatives, such cost saving discounts continue to lower the cost for as long as premiums are paid.


Finally, there are both federal<sup>2</sup> and state<sup>3</sup> tax advantages for long term care insurance. In general, self-employed individuals can deduct 100% of eligible long term care insurance premiums<sup>4</sup> and employers can provide long term care insurance as a tax free benefit. Furthermore, the recently passed Medicare Modernization Act treats long term care insurance as a medical expense for purposes of the new Health

Savings Accounts that are available for individuals with high deductible health insurance plans.

### The Challenges of Caring for our Elderly Parents

any attorneys are not only responsible for their professional responsibilities and caring for their own families, but are now facing additional challenges of caring for their aging parents. The WBA has focused on this challenge and has hosted several programs to help attorneys face these challenges head on. Working Parents and Tax & Business Forums hosted a program entitled "Caring for our Elderly Parents" featuring professionals from Potomac Home Health<sup>1</sup>, Potomac Home Support<sup>2</sup>, and Care Management Associates, LLC<sup>3</sup>. Members of the panel included Judy Zietler, a social worker; Susan F. Johnson and Angie Ortega, registered nurses; Katherine Campbell, occupational therapist; and Jacqueline G. Lapidus, psychologist. Geraldine Gennet, a WBA member, also shared her experience in caring for her own elderly parents.

The speakers explained the many challenges we encounter when our parents cannot live independently, or suffer from a terminal illness or a chronic degenerative disease. Care management professional help families through these challenges, provide useful information and coordinate with other care providers. Care managers will stress that often things are negotiable. Care managers coach families on their choices, and assist inding the best means of payment (insurance, Medicare<sup>4</sup>, Medicaid). In addition, families need to educate themselves about medication, medical equipment and supplies, and health insurance coverage.5

Care managers also provide expertise to families in the selection of an independent living facility, nursing home, assisted living facility, continuing care retirement community or home care services. Care facility costs vary from \$5,000 to \$7,000 a month depending upon the service offered and location. Judy Zietler recommended the quarterly magazine Guide to Retirement  $\underline{\text{Living}}^{6}$  as a useful resource. It provides a map with the list and phone numbers of all the institutions providing elder care in the Washington, D.C. Metropolitan area.

The presentation also addressed the importance of assessing not only our parent's financial and legal situation, but also our own. It is important to review and update all legal documents (Health Care Proxy or Durable Power of Attorney for Health and Finance; Living Will or Advance Directive) before there is a necessity. A consultation with an elder law attorney can be very beneficial, too. Elder law attorneys7 focus on the elderly clients and how best to assure their quality of life during their final years, as well as the assets they leave behind. They can provide important services when an ill parent requires institutionalization, but the other parremains healthy and requires sufficient funds for the remainder of his or her life. Often an attorney specializing in elder law will work with a financial planner, an insurance specialist, and/or a care manager, as well.

While it is difficult to face the problems of aging parents or contemplate our own aging process, advanced planning and the use of care managers can ease these burdens.

#### Celebrating Our Past

Notes from January/February Meetings of the WBA Board of Directors

n January 8, 1918, the WBA Board unanimously adopted a motion authorizing the WBA Legal Aid Committee to cooperate in organizing the Legal Aid Bureau or Society of the District of Columbia. (The Legal Aid Society of the District of Columbia was eventually launched in 1934 to provided legal representation to those who can least afford it.)

On January 19, 1926, the WBA Board heard the report of the Committee to Confer with the Men's Bar of DC with reference to a bill relating to the contractual relations of married women. The Board approved the Committee's recommendation that the President appoint a committee to follow up and support the passage of this bill.

On February 17, 1931, the Board discussed options for a permanent headquarters for the association. One option was to rent a room at the Women's City Club for \$25 per month, although the Board decided it would be wise to investigate the use of a room at the Court House.


