
SENATOR DEBBIE STABENOW TO DELIVER ANNUAL DINNER KEYNOTE

US Senator from Michigan a Rising Congressional Star

he Honorable Debbie Stabenow, who made history in 2000 when she became the first woman from the State of Michigan elected to the United States Senate, will deliver the Keynote Address on May 18, 2004 at the Annual WBA/WBAF Awards Dinner, From the Right to Vote... To Winning the Vote: Women in Leadership.

Senator Stabenow serves on four key Senate committees including the powerful Budget Committee; Banking, Housing and Urban Affairs; Agriculture, Nutrition and Forestry; and the Special Committee on Aging. Her public service record dates back to 1974 when she was first elected to the Ingham County, Michigan Board of Commissioners, where was the youngest person and first woman to chair the Board (1977–78). She was elected to the

Michigan House of Representatives where she served for twelve years (1979–90) and rose in leadership,



Senator Stabenow champions a variety of issues ranging from the protection of Medicare to job creation to the rights of victims of crimes. "As a co-sponsor of the Crime Victims' Rights Act, I

Owning Your Own Business - the RISKS & REWARDS!

hat an exciting opportunity and some great ideas were shared at the most recent WBA Career Development Committee Luncheon, "Owning Your Own Business." Our three fabulous presenters shared their success with the attentive audience. Thank you to Eileen M.

Ellsworth, Executive Director of Empower Girls, Inc., Lisa Dunner, Esq. of Dunner Law and Mary W. Legg, President & General Counsel of Firm Advices, Inc. All three presenters indicated it was a difficult decision but after taking the plunge, they have not looked back.

Eileen Ellsworth, formerly a General Counsel, is the Executive Director of Empower Girls Inc. She indicates it is extremely exciting to work on your own and the challenges you may face. Eileen became aware of an imbalance in the number of girls and boys attending technology classes and decided to bridge that gap. She did some research and obtained non-profit status to close the gender gap in middle and high school computer and technology related courses of study. Eileen stressed the importance of research, net-working and preparation to make a successful transition.

Lisa Dunner started the Dunner Law firm less than a year ago, and according to her, it "is the best thing [she] has ever done." Lisa stressed the importance of due diligence prior to starting your own firm. For Lisa, this included talking to many of her solo practitioner friends, calling the D.C. bar for advice on certain matters, and making lists of necessary start up costs and equipment, as well as operating costs and equipment. Lisa also emphasized the importance of establishing relationships not only with existing clients, but colleagues and friends. It is these relationships that led Lisa's clients to follow her from her prior firms to the Dunner Law firm.

It is also these relationships that has led to referrals from her clients, her professional colleagues and her friends.

Lisa emphasized the importance of staying involved in Bar activities, and she spends a significant amount of time as

activities, and she spends a significant amount of time as
Treasurer for the Women's Bar Association and as an officer of
the American Bar Association. She believes that these activities
keep her visible and connected, because as a solo practitioner, it

would be so easy to go into your office and just shut your door. While it is not always easy being on your own, Lisa discussed the pros and cons of bigger law firm life versus solo practioner life. In Lisa's opinion, the benefits of being solo far outweigh the benefits of the bigger firms. Although, Lisa admits that she could

not have done what she is doing now without the big firm training she had.

Mary Legg offered that the key to getting her company started was making just one step every day towards establishing her company. Those steps included calling an attorney friend to set up an appointment to meet and incorporate her company, to speaking with a graphic artist about a logo for her company, to ordering business cards. According to Mary, breaking the process of setting up her company into small steps resulted in minimal anxiety and the establishment of her company surprisingly quickly. Once the company was established, it was clear to her that the right thing to d was to launch the company, and has been doing business now for over four years.

Mary emphasized that having your own business is not easy. The skills that have most come into play to have a successful company are enjoying people and networking, ability to juggle many projects and responsibilities, being efficient, and above all, having perseverance. Additionally, unlike what many envision owning your own business to be, you are not your own boss; your clients are your bosses. However, you do have the ability to choose your bosses and office politics are minimized. Another benefit Mary enjoys in having her own business is that she establishes the rules and she has more control over her professional destiny.

This emphasizes for all of us to take a look at where we are and where we would like to aspire!

WBAF GRANT RECIPIENT CHAMPIONS WOMEN'S PUBLIC INTERESTS

he Women's Law and Public Policy Fellowship Program was one of the non-profit organizations awarded grants by the WBAF this year. Founded in 1983, the program recruits talented and committed U.S. law graduates and brings them to Washington, D.C. for a year to work for organizations involved in legal and policy issues affecting women. Over 180 women and men have participated in the U.S. program by serving as Fellows at more than 50 public interest organizations. Critical issues that the Fellows have tackled include domestic violence, civil rights, sex discrimination and harassment in the

workplace, the problems of women in prison, women in poverty, and women with disabilities.

The Women's Law and Public Policy Fellowship Program has been recognized by many of the most influential women in the legal profession, including The Honorable Ruth Bader Ginsburg, one of the program's earliest and most vigorous supporters. According to Justice Ginsburg, "If you want a group of lawyers to become interested in public service and women's equality, you couldn't do it any better than this."

The Women's Law and Public Fellowship Program is funded by foundation grants and public contributions. The program is administered by a board of women's rights advocates, chaired by Eleanor Holmes Norton, Member of Congress for the District of Columbia, and including Marcia Greenberger, Co-President of the National Women's Law Center; Judith Lichtman, President of the National Partnership for Women and Families; Wendy Webster

Johanna brings her own deep connection to the Program and its issues, together with her experience as an international women's rights activist and scholar.

in the political process. She served as the Campaign Manager to Gore-Lieberman 2000 — the first African-American to lead a major presidential campaign. Prior to joining the Gore campaign, Ms. Brazile was Chief of Staff and Press Secretary to DC Congresswoman Eleanor Holmes Norton. Ms. Brazile is a weekly contributor and political commentator on CNN's Inside Politics and American Morning as well as a regular participant on MSNBC's Hardball and Fox's Hannity and Colmes. She is currently the founder and managing director of a political consulting and grassroots advocacy firm based in DC — Brazile & Associates.

As the 1984 Democratic nominee for Vice-President, Geraldine Ferraro secured a place in history as the first woman candidate for that office on a national party ticket. She was first elected to Congress from



elected to Congress from New York's Ninth Congressional District in Queens in 1978 and served three terms in the House of Representatives, where she spearheaded efforts to achieve passage of the Equal Rights Amendment and sponsored the Women's Economic Equity Act. From 1994–1996, Ms. Ferraro served as the United States Ambassador to the United Nations Human Rights Commission, appointed by President Clinton. Ms. Ferraro was a co-host of CNN's Crossfire for two years and is currently a political analyst for Fox News and a columnist for the New York Times Syndicate. Ms. Ferraro now heads the Public Áffairs practice of The Global Consulting Group, an international investor relations and corporate communications firm.

LINDA G. FORD

'ORIAN AND AUTHOR "IRON-JAWED ANGELS"

Linda Ford is an historian of women, a former history professor and an antiquarian bookseller. She authored Iron-Jawed Angels: The Suffrage Militancy of the National



Woman's Party, 1912–1919, which recounts the struggle to secure the right to vote for women. Her book was the subject of a recent HBO movie of the same name. Ms. Ford's most recent work is called Lady Hoopsters: A History of Women's Basketball in America.

She has worked at Common Cause, served as press secretary for the National Women's Political Caucus, and as press secretary for Esther Peterson in the 1980 White House staff, President Jimmy Carter's special assistant for consumer affairs. Since its founding, EMILY's List has helped send 11 pro-choice Democratic women to the U.S. Senate, 55 to the U.S. House of Representatives and seven governors. EMILY's List is the largest political action committee in the country and raised more than \$24 million in the 2002 election cycle to help candidates build effective campaigns, bring new women into the political process, and encourage women to vote.

KAY J. MAXWELL

PRESIDENT OF THE LEAGUE OF WOMEN VOTERS OF THE UNITED STATES

Kay J. Maxwell is the 16th president of the League of Women Voters of the United States (LWVUS) and chair of the League of Women Voters Education Fund (LWVEF). During her 25 years of service with the



League of Women Voters, Ms. Maxwell has held numerous leadership posts at different levels within the national organization. She has conducted training of women leaders in Bosnia and was the Oversight Trustee for several League international programs. Ms. Maxwell's international community service led her to become an active participant in the U.S. Department of State's International Speakers Program. Since 1999, Ms. Maxwell has traveled to Israel, the West Bank, Rwanda, Kuwait and Jamaica, to conduct civic participation training sessions for women political, NGO and business leaders.

As Chair of the Congressional Caucus for Women's Issues, she advanced efforts to promote access to micro-enterprise capital among women in developing countries. Her career in public service began with her appointment to the first-ever Montgomery County, Maryland Commission for Women in 1972. Ambassador Morella was elected to the Maryland General Assembly in 1978 and became the first woman member of the Assembly ever elected to the U.S. Congress.

BETTY SOUTHARD MURPHY, ESQUIRE

Publishers (AAP), national trade organization of the U.S. book publishing industry, Mrs. Schroeder left Congress undefeated in 1996 after representing Denver, Colorado, in the United States House of Representatives for 24 years. In 1988, she considered running for President for three months and was third in a Time magazine poll when she withdrew for lack of funds. From January to June 1997, she held the rank of Professor at the Woodrow Wilson School of Public and International Affairs at Princeton University, before assuming her post at AAP. Mrs. Schroeder attended Harvard Law School as one of only 15 women in a class of more than 500 men. She earned her J.D. and moved to Denver, Colorado, with her husband James, who encouraged her to challenge an incumbent Republican for Colorado's First Congressional District seat in 1972.

SUSANNAH WELLFORD SHAKOW PRESIDENT & CO-FOUNDER OF WOMEN UNDER FORTY POLITICAL ACTION COMMITTEE

Susannah Wellford Shakow is the President and cofounder of Women Under Forty Political Action Committee (WUFPAC), a nonpartisan political action committee dedicated to bringing young women to



politics, both by supporting young women Congressional candidates, and by encouraging young women to make politics more a part of their lives. WUFPAC, a bipartisan organization, is the only political action committee in the United States devoted to helping young women of all parties run for elected office. The PAC has helped elect Sen. Blanche Lincoln, and Congresswomen. Tammy Baldwin, Melissa Hart, Linda Sanchez, Loretta Sanchez, Mary Bono, and Heather Wilson. Ms. Shakow is an attorney, formerly practicing legislative law with Verner, Liipfert, Bernhard, McPherson & Hand. She has served as a Legislative Assistant to Senator Wyche Fowler from Georgia, in the policy and communications offices in the White House on President Clinton's Health Care Initiative, and as a Special Assistant to the Director of the Office of Disease Prevention and Health Promotion at HHS.

SUSAN TURNBULL DEPUTY CHAIR OF THE DEMOCRATIC NATIONAL COMMITTEE

Susan Turnbull is the DNC Deputy Chair, appointed in Fall 2003. She has been an active
