
2005 Annual Awards Dinner A Rousing Success

On May 17, 2005 close to 1000 members of the Washington DC legal community attended the WBA/WBAF 88th Annual Awards Dinner, "From Neighborhoods to Nations: Women Leading the Way". From the opening moments of the cocktail reception to the closing remarks from now WBA President Karen Lockwood, the evening was filled with energy, compassion, enlightenment and friendship!

WBA President Joanne Young commenced the program by thanking the WBA Board and Committee and Forum Co-Chairs for a fabulous 2004-2005 year. Throughout the 2004-2005 year, the WBA was host to numerous programs focused on a woman's role both as a leader and seeking leadership-including the 2004 Stars of the Bar Networking Reception; the 2004 Presidential Appointment Process and the 2005 Women Partners' Dinner. WBAF President Diane Brenneman then spoke of the important work accomplished by the 2004-2005 WBAF Board, and announced the 2004-2005 WBAF grant recipients, including the WBA, the ABA Commission for

Women, GWAC, DC Employment Justice Center, PLEN, Women Empowered Against Violence; and The Empower Program-Girls Leadership Institute Program.

Senator Kay Bailey Hutchinson provided the keynote address, and focused her remarks on the role of women as leaders in the both the domestic and international arenas. Senator Hutchinson reiterated the need for women, and in particular, women in the legal profession, to step up and take on leadership responsibilities.




WBA President Joanne W. Young presents the Woman Lawyer of the Year Award to the Honorable Noel Anketell Kramer.

The Board, in its July 11, 2005 meeting, approved a roster of Committees and Forums that will be active during 2005-06.

Those committees and forums are being formed, and will be featured at the Stars of the Bar kick-off reception on September 22. It enthusiastically welcomes all interested persons to join committees and forums of interest to them. A woman's participation in our committees is the most significant doorway to leadership of the committee or forum, and ultimately to elected office in the Association!

Committees and Forums Are The Essence of the WBA

The Committees and Forums represent the backbone of the Association. Committee-planned events represent the overwhelming majority of WBA programs. Those events are open to everyone, not just WBA members. They have been widely recognized over the years as some of the finest and most consistently interesting events available to bar members. The Association is our committee and forum work, and the women who co-chair those committees have significant autonomy in which to exercise their creative insight and make new contacts while planning exciting WBA events.

The committees, which are Standing Committees under the Bylaws, will be divided between committees of the Board and committees of the membership, as appropriate to reflect the mission of the committee's work this year. (Displayed in Sidebar on page 14.) In addition, the year will begin with fifteen Forums, which cover a panoply of interests of special interest to women lawyers or focused on a substantive area of legal practice.

The co-chairs for many of the committees and forums already are planning specific programs for the year. The Leadership Retreat, held on July 22, 2005, focused particularly on the committees and forum process and ways in which the Officers and Board can advance and assist the success of committee events.

Some Leadership Positions Remain Available

The final organization of committees and forums is still open. There remain available a few co-chair positions, and there are many roles for committee members to become involved in the networking and imagination that goes into planning WBA events. In addition, the Board encourages any member having special background in the areas of membership and public relations to contribute to the ongoing Board projects by contacting any Board member.

SANDRA DAY O'CONNOR

On September 25, 1981, we watched as one of us became a United States Supreme Court Justice - Sandra Day O'Connor was sworn in as the first woman Justice on the Court. Justice O'Connor is truly one of us. She is a member of the National Association of Women Judges and the Arizona Women Lawyers' Association. She is a recipient of our very own Torchbearer Award from the WBADC in 1997. She has honored us with her presence on numerous occasions: to present an award (1994), participate on the Lawyers at Home panel (1996), speak at the Judicial Reception (2002), and more.

Justice O'Connor received her law degree from Stanford University in 1952, graduating third in her class. She was a member of the Order of the Coif and the Board of Editors of the Stanford Law Review; but no law firm in California would extend her an offer - as an associate attorney, that is. As the story goes, one law firm offered her a position as a legal secretary. Thoroughly undeterred, Justice O'Connor began her legal career as deputy county attorney in San Mateo, California, and went on to practice in many other venues, including her own law firm, and as assistant attorney general, state senator, county court judge and on the Arizona Court of Appeals. As an Arizona state Senator, she was the first woman elected as Senate Majority Leader, in 1972.

From her first year on the Supreme Court, when she received over sixty thousand letters from the public, Justice O'Connor has received national prominence. As a centrist on the Court and a pragmatist, she has been a deciding vote for many of the cases she has heard. Whether we agree with her decisions or respectfully disagree, Justice O'Connor's leadership, her persistence in the face of adversity and her continued support of the next generations of women lawyers make her a model and an inspiration for all of us. And so, as her record of accomplishment on the Supreme Court of the United Stats comes to a close, we expect to see Justice O'Connor continuing to break ground wherever she goes. To borrow a phrase from WBA President Karen M. Lockwood: "she will continue to be a force in the law, in justice, and for women in the law The Women's Bar Association of the District of Columbia thanks and salutes Justice O'Connor, jurist, leader, and friend."


Rebecca McNeill, Treasurer-Elect







NAWL'S ANNUAL AWARD LUNCHEON

Birmingham Board of Education in which the Supreme Court affirmed that Title IX precludes retaliatory firing. NAWL also submitted briefs on domestic violence issues (in Town of Castle Rock v. Jessica Gonzales again in the Supreme Court) and on issues involving gender equality.

A New Approach to Women's Communication

"I did my research. I was ready for the meeting. Yet when I opened my mouth, the talking points and ideas that were so clear in my head fell flat on the table. I'm smart. I've taken a public speaking class. Why does this happen to me?"

If you walk into meetings and negotiations feeling capable and well-prepared, yet walk away feeling unheard, you are not alone. You are also in good company if you've ever been bypassed after proposing a brilliant idea, only to hear that idea met with enthusiastic response when later presented by a colleague.

Despite consistent academic and professional success, women often experience a disconnect between their knowledge and their ability to communicate their ideas in the workplace adversely affecting performance and advancement opportunities. Key findings from Catalyst Inc.'s landmark study Women in Law: Making the Case for Change place "demonstrating strong communication skills" as the top advancement strategy for lawyers.

But is there more to effective communication than good eye contact, knowing your audience, and a thorough detox of the um's and uh's? Do the classic public speaking 101 tips really address a woman's experience of voice at work? Why is workplace communication more complicated and challenging for women?

A woman's experience of voice is influenced by a complex web of factors that include social, developmental, educational and cultural influences specific to women. These factors manifest themselves in physical, emotional, and intellectual obstacles that can hinder a woman's success in connecting clear ideas with confident communication. During any given workplace conversation - whether with clients or colleagues- these factors are at play and affect how, or even if, a woman presents her ideas, how she makes meaning of the conversation and how she values her knowledge and its relevance to the conversation.

While women remain hopeful of one day achieving a critical mass as partners, they continue to function in a communication landscape that has been designed and established by men. If the number one advancement strategy for partnership focuses on strong communication skills, how can law firms recognize and support the advancement of women in the field without first acknowledging women's broader experience of voice at work?

COURAGE TO PROMOTE JUSTICE

As members of the Women's Bar Association of the District of Columbia, we appreciate women advocates who lend their voice to promote equality and justice in the world. Mukhtar Mai is an advocate who rightfully deserves the international spotlight that has been cast upon her. Taking a brave stance against the men who gang raped her three years ago on the orders of a village tribal council, Mai has advanced her case to the highest level of Pakistan's judicial system.

After a three-year legal battle with her alleged rapists, Pakistan's Supreme Court recently agreed on June 28th to rehear Mai's case. While this decision was not on the merits, it breathes new life into Mai's case and gives her a chance at justice against those who mistreated her. In 2002, Mai suffered the consequences of a tribal council's response to allegations that her 12-year-old brother had been seen in the company of a woman from an influential local tribe. Mai was called to the council to apologize for her brother's conduct. She appeared and apologized, but was dragged to a nearby hut and gang raped allegedly by four men. Shortly thereafter, 14 men were arrested and charged under various provisions of three laws that extend the crime of rape to all those who were present on the occasion and had abetted the crime. Of the 14 men charged, six men were charged by the trial court to death, and eight were acquitted. Mai filed an appeal against the acquittal of the eight men who were set free. On March 3, 2005, the appellate court reversed the trial court's decision, claiming that there was insufficient evidence and a faulty investigation. The appellate court subsequently acquitted five of the six men who were sentenced to death, and commuted the sixth man's sentence to life imprisonment. With the help of her attorney, Aitzaz Ahsan, Mai appealed to


President Musharraf and Pakistan's Supreme Court in fear for her life at the release of the men who were previously detained. Her victory, at this point, is evident in that all fourteen men are still being detained pending retrial.

Mai's courage in standing up to the tribal judicial system and her attackers is impressive for many reasons. Many women in Pakistan and other parts of the world suffer silently as they are humiliated and abused needlessly at the direction of local officials. Mai gained strength from the support of many members of her community who wanted to change the status quo. This gave her the confidence to fight and bring attention to her situation, despite being poor and illiterate.

Mai has made great strides to improve the status quo in her village. With the compensation awarded to her from the trial court, she established two schools in her village. Through these schools, she seeks to improve the minds of boys and girls so that they are aware of their rights and duties. Mai is also seeking to improve women's rights through international campaigning.

Mai is a role model for women advocates all over the world. Her fight and victories to date will likely inspire many women to speak out for women's rights. There is no way to measure the effect of one Mai, but hopefully many will follow her lead and seek justice so that there is no more suffering in silence.




