

I recently had the pleasure of attending the annual luncheon sponsored by the Washington Area Women's Foundation (WAWF) where they unveiled their most recent Portrait Project Report on the status of women and girls in the Washington Metropolitan region. The WAWF released its prior report in 2003. That report painted a very sobering picture of the challenges women and girls face in our community. The 2010 report surprisingly did not show much improvement.

I was shocked to learn that in this rich community in which we live and work, more than 177,000 women and children live below the federal poverty line; in 2009 domestic violence service programs in DC, Maryland, and Virginia were forced to turn away 600 victims a day due to lack of staff; the teen pregnancy rate in DC is more than twice the national average; and nearly two-thirds of female-headed households with children in the Washington region have unaffordable housing costs, which, coupled with child care, leave little room for essentials like food and clothing. These are just a few of the startling statistics in the WAWF report.

The release of this report underscored for me the importance of the work of the Women's Bar Association Foundation (WBAF) and the need for the WBAF to increase the amount of its own giving and expand the number of worthy organizations in our community that receive WBAF grants. To that end, I am thrilled to report that the Foundation has received three times the number of initial grant requests this year than last, and that the requests were received not only from past grant recipients and applicants, but also from many new potential grantees. The majority of potential applicants have been asked to submit a full grant proposal by December 15, 2010. We look forward to reviewing these applications and to visiting as many of the organizations on-site as possible.

But we cannot do our work alone. We need the support of our sisters in the WBA to help us build our grants pool and expand our reach. As the philanthropic arm of the WBA, we are your voice in the community. Please make a generous donation to the WBAF this year. Maribeth Raffinan Confirmed to DC Superior Court


